We also connect with and provide assistance to teachers, staff, administrators, community members and partners to start and grow local GSAs.

(Health and Wellness) Peer Health Fellowship: The Peer Health Fellowship offers youth ages 13-24 the opportunity to be leaders in their schools and communities as health educators. Fellows serve their community as role models, leaders, and trusted friends by distributing condoms and safer-sex information, promoting HIV testing, and organizing youth-led workshops for peers and providers throughout the year. Clinical Services: SMYAL offers clinical services to LGBTQ youth ages 6-24 which includes individual therapy, group sessions, trauma-enforced yoga, sound healing and mindfulness.
